# **COVID-19 Small Business Micro Grant Program Fund Elizabeth City, NC**

Small businesses across our City are being negatively affected by the economic effects of COVID-19 and are experiencing a financial crisis as a result. Lost income and unrecoverable expenses are causing immediate hardship for our community's small businesses. These businesses support thousands of local jobs, collect sales tax revenues, pay property taxes, and otherwise contribute to our economy and tax base.

We all play an important role in ensuring that our local economy survives this pandemic. We are committed to doing whatever we can to support our business community and try to alleviate some of the immediate need caused by the forced closure of their businesses and reduced revenue.

Our goal with the COVID-19 Small Business Micro Grant Program is to help our neighborhood independent small businesses maintain their livelihood and continue to foster a vibrant and strong community.

The Elizabeth City governing body would provide the seed money for the stimulus COVID-19 Small Business Micro Grant Program Fund. The fund would be created, and the program administered by Elizabeth City Downtown, Inc. (ECDI) a 501(c)3 non-profit entity with a proven reputation for the revitalization of downtown and supporting small businesses. ECDI has experience in managing and administering grant funds in a manner that is consistent with City Standards. Other entities, organizations, business, or individuals will be invited to contribute to this fund A Grant Committee will be established to review and process applications. This Grant Committee will be a subcommittee of ECDI. The members of the Grant Committee will represent the demographics of our community. ECDI's Grant Committee will establish guidelines that will be used to score the applications. These guidelines will be included in the grant application package.

This program is for business assistance to small for-profit businesses located within Elizabeth City. Awards are not intended as unemployment assistance. Funds may be used for business related expenses including rent, mortgage payments, utility expenses, working capital, or other similar expenses that occur in the ordinary course of business.

Interested small businesses can apply for this grant by completing a short application and providing the necessary documentation. A combination checklist and scoring rubric will be used to evaluate applications. For those applications determined to be eligible for grant funds, awards will be disbursed as quickly as possible, until the fund is depleted. Once the fund is established, an initial grant deadline will be established. If funds are remaining after the initial round of grants are awarded, a second round will be established.

**Grant Amount**: Not to exceed \$1,500 per business

#### Application Deadline: April 22, 2020

Grant applications are due by April 22, 2020. Applications received after the deadline will be considered if funds remain available. Applications will be scored on criteria determined by the ECDI Grant Committee. Awards will be disbursed as quickly as possible with priority given to applications completed and submitted by the deadline. Grants will be awarded until the fund is depleted.

ECDI's Grant team will be available to work with applicants in cooperation with partner organizations such as the Elizabeth City-Pasquotank Economic Development Commission, Small Business & Technology Development Center, COA's Small Business Center, Eastern Women's Entrepreneurship Center, The Elizabeth City Area Chamber of Commerce, River City CDC, and/or SmartUp and other entities or organizations to assist business owners in putting together their applications. These agencies/partners will also help to assist business owners with other possible resources.

### An eligible small business should:

- Be a for-profit business with a valid business license and zoning permit and operate within the City Limits of Elizabeth City, NC
- Operate under one of the following legal structures: Sole proprietorship, LLC, LLP, LP, Corporation (Franchises, publicly traded companies or subsidiaries of publicly traded companies, and non-profit entities do not qualify.)
- Have been in operation and show revenues for at least the past six (6) months
- Have a brick-and-mortar location (home-based businesses do not qualify)
- Be service or retail establishments open to the general public
- Have at least one payrolled employee and no more than 50 employees (excluding contract service workers and those employees paid on 1099 status). If a business is a sole proprietorship and the owner is the sole employee (i.e., self-employed) they may qualify if it can be demonstrated that rent, mortgage and business operating expenses are paid to third party entities with no ownership or financial ties to the applicant).
- Have annual gross revenues of less than \$2 million
- Be a company or business in an industry outlined in the NC Governor's Executive Orders 116 and 120, or any subsequent Executive Order ("EO") of similar intent, or demonstrates that it is otherwise affected by the COVID-19 outbreak.
- Demonstrate a loss of revenue of 25% or more\*
- Must be current on taxes owed to the City and the County as of February 1, 2020.
- Signed affidavit indicating the intended use of grant funds and a commitment to spend within 30 days of receipt.

In the instance of multiple businesses located in one establishment with one address, such as a business co-operative, the business entity that holds the lease or mortgage for the space may apply.

#### \*Determination of Revenue Loss:

Comparison of average revenue for the two full months of operation prior to the issuance of the respective Executive Order (116, 120, or subsequently issued EO) affecting the business and/or the Declaration of the State of Emergency to the month of operations immediately after.

#### The following supporting documents will be required:

- Copy of valid business license and zoning permit within the City limits of Elizabeth City
- Articles of incorporation or any documentation showing the business' legal structure
- Financial documents:
  - \*Financial documents showing revenue by month for at least two full months of operations prior to the Executive Order affecting the business and/or the declaration of the State of Emergency. (The more revenue data you can provide, the better)

- \*Financial documents showing revenue for at least one month of operations after the Executive Order affecting the business and/or the declaration of the State of Emergency.
- Other documents as requested by Committee that help to determine eligibility and provide clarification.

\*Financial documents can include: point of sale reports, bank statements, quarterly sales tax filings, tax returns, CPA-certified profit and loss statements, or financial information reviewed and signed certified by a partner business organization such as the Elizabeth City-Pasquotank Economic Development Commission, Small Business & Technology Development Center, College of the Albemarle's Small Business Center, Eastern Women's Entrepreneurship Center, The Elizabeth City Area Chamber of Commerce, River City Community Development Corporation and/or SmartUp. All financial documents and proprietary business information submitted will remain confidential.

Grant team will work with applicants in cooperation with partner organizations such as the Elizabeth City-Pasquotank Economic Development Commission, Small Business & Technology Development Center, COA's Small Business Center, Eastern Women's Entrepreneurship Center, The Elizabeth City Area Chamber of Commerce, and/or River City CDC, and other entities or organizations to assist business owners in putting together this information if they don't have it. It is important to consider, however, that completed applications submitted with all relevant data will get processed faster. These agencies/partners will also help to assist business owners with other possible resources.
